

On June 4, 2013 the City of Oswego, Kansas, adopted Ordinance No. 1314 amending the City Code of the City of Oswego, Kansas. This section allows for the City of Oswego to annex land owned by the City of Oswego to be used for a housing development. ORDINANCE NO. 1314

AN ORDINANCE ANNEXING LAND TO THE CITY OF OSWEGO, KANSAS, THE UNPLATTED LAND DESCRIBED HEREIN, WHICH LAND IS OWNED BY THE CITY OF OSWEGO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OSWEGO, KANSAS:

SECTION 1. That the unplatted land, which is owned by the City of Oswego, is described as follow, to-wit:

The West Half of the Southeast Quarter of the Northwest Quarter; the East 20 rods of the Southwest Quarter of the Northwest Quarter; and beginning 20 rods West of the Southeast corner of the Southwest Quarter of the Northwest Quarter, thence West 17 rods, thence North 80 rods, thence East 17 rods, thence South 80 rods to the place of beginning, all being located in Section 21, Township 33 South, Range 21 East, except roadway 30 feet wide of South line of above described tract and except a grant to the City of Oswego, Kansas, for sewer and septic tank privileges, Labette County, Kansas, AND


The West 21 ½ acres of the Southwest Quarter of the Northwest Quarter of Section 21, Township 33 South, Range 21 East of the 6<sup>th</sup> P.M., except commencing at the Northwest corner of the Southwest Quarter of the Northwest quarter of said Section 21, thence East 43 rods thence South 8 rods, thence West 14 rods, thence South 28 rods, thence West 29 rods, thence North 36 rods to the place of beginning, ALSO EXCEPT so much thereof as is used for public highway or road, Labette County, Kansas.

SECTION 2. The Governing Body finds that pursuant to K.S.A. 12-520(2) that the land is owned by the City of Oswego and that pursuant to K.S.A. 12-520a(f) no resolution, notice or public hearing is required for the annexation of land owned by or held in trust for the city or any agency thereof or land all of the owners of which petition for or consent thereto in writing.

SECTION 3. The above described land is hereby annexed into and made a part of the corporate limits of the City of Oswego, Kansas.

SECTION 4. This Ordinance shall take effect and be in force from and after its passage, approval and publication in the official City paper.
